## Registrations of used passenger cars fell by 3.2% in the first half of 2023

4.1% less diesel and petrol cars, increase of 8.7% for alternative drives

Vienna, 2023-07-14 – According to Statistics Austria, 380 567 used passenger cars were registered in the first half of 2023, a decrease of 3.2% compared to January to June 2022. The overall 489 809 registered used motor vehicles also translate to a decline of -3.9% compared to the the first half year 2022.

The year 2023 started with a decline in registrations of used cars in January (-8.4%) and February (-16.5%). In March (+1.5%), an increase was observed for the first time. Another drop by 6.4% in April was followed by positive year-on-year registration figures again in May (+0.9%) and June (+9.5%).

There were fewer registrations of used **cars** with electric drive (8 193; –10.1%), cars with petrol drive (incl. flex-fuel; 142 584; –4.1%) and diesel cars (208 206; –4.1%). On the other hand, registrations of used hybrid passenger cars increased compared to the first half of 2022 (petrol-electric: 15 528, +12.4%; diesel-electric: 5 728, +38.2%). Overall, registrations of used passenger cars with alternative drive systems (29 777) rose by 8.7% and reached a share of 7.8%. Petrol passenger cars (incl. flex-fuel) accounted for a share of 37.5% and diesel passenger cars for 54.7%.

The top 10 **makes** in terms of used passenger car registrations from January to June 2023 were led by VW (share: 19.8%), followed by Audi (share: 9.8%), BMW (share: 9.4%), Mercedes (share: 7.1%) and Skoda (share: 6.0%). Increases were observed for Skoda (+7.0%) and Mercedes (+1.5%). Registrations declined for Renault (-12.9%), Opel (-9.0%), Peugeot (-6.4%), Audi (-3.2%), VW (-2.9%), BMW (-2.5%), Ford (-1.1%) and Seat (-0.3%).

In the **commercial vehicle market**, there were consistently fewer used registrations compared to the first half of 2022, with 29 067 class N1 lorries (-6.2%), 11 270 tractors used for agriculture and forestry (-5.3%), 925 articulated lorries (-1.2%), 1 336 class N3 lorries (-1.1%) and 313 class N2 lorries (-0.6%).

The number of used **two-wheeler registrations** also declined, with 40 924 motorcycles (-6.3%) and 17 589 mopeds (-8.8%).

**Information on methodology, definitions:** Motor vehicle statistics (registrations of new and used vehicles as well as the stock of vehicles) are secondary statistics, compiled on the basis of daily data files sent to Statistics Austria by Austria's association of insurance companies (VVO). VVO, in turn, receives data by the insurances' registrations offices, responsible for registrations, de-registrations and rectifications of motor vehicles and trailers. The statistics of used vehicle registrations cover all registrations of vehicles that have already been registered, regardless of the duration of the registration.
