# Freight traffic on the road decreased in 2022

Amount of transported goods lower than in the pre-pandemic year 2019

Vienna, 2023-10-12 — Domestic and foreign road freight vehicles transported a total of 590.9 million tonnes (t) on Austria's roads in 2022, as Statistics Austria reports. This means that the transport volume decreased by 3.1% compared to the previous year. After the strong increase in freight volumes in 2021, there were declines in all transport types except transit transport in 2022.

After freight transport on Austria's roads reached more than 600 million t for the first time in 2021, the **amount of goods** measured in 2022 was with 590.9 million t by 18.6 million t lower than in the previous year (609.5 million t). Thus, the transport volume was even 1.2% below the pre-crisis value in 2019 (598.0 million t). Multiplied by the distances travelled, this resulted in a domestic **transport performance** of 56.2 billion tonne-kilometres (tkm). This is 1.2% less than in 2021, but 3.1% more than in 2019 (54.5 billion tkm).

While the amount of goods carried by **Austrian vehicles** decreased by 3.2% to 385.1 million t compared to the previous year (398.0 million t), the decline in domestic transport performance was lower with –1.9% to 19.2 billion tkm (2021: 19.6 billion tkm). The transport volume of **vehicles registered abroad** dropped by 2.7% to 205.8 million t (2021: 211.4 million t), the domestic transport performance fell by 0.8% to 37.0 billion tkm (2021: 37.3 billion tkm).

### Transport volume in transit transport increased slightly

In 2022, **transport volume** decreased in all types of transport except transit transport. **National transport**, which accounted with 372.5 million t for the main part of the transport volume, dropped by 3.1%. **International receipt** (69.5 million t) and **dispatch** (62.8 million t) showed a decline by 6.2% and 3.9% compared to the preceding year. In 2022, **transit transport** (86.1 million t) recorded a plus of 0.5% in comparison to 2021.

Almost two thirds of the total **transport volume** (65.2% resp. 385.1 million t) was performed by **Austrian road freight vehicles**. While national transport was carried out primarily by Austrian vehicles (97.4% and 362.8 million t respectively), the share of domestic road freight vehicles in international receipt and dispatch reached only 14.8% (10.3 million t) and 17.3% (10.9 million t). With 1.3% (1.1 million t), Austrian vehicles contributed only marginally to transit transport.

In total **domestic transport performance**, the share of foreign freight vehicles was with 65.8% (37.0 billion tkm) significantly higher than that of Austrian freight vehicles (34.2% or 19.2 billion tkm). This is mainly due to the long journeys foreign vehicles conduct in transit transport. More than one third of the total transport performance (20.3 billion tkm) was carried out in transit transport, of which a share of 99.3% was performed by foreign vehicles.

Information on methodology, definitions: In accordance with Regulation (EU) No 70/2012 of the European Parliament and of the Council of 18 January 2012 (amendment of Regulation (EG) No 1172/98), all EU member states have to collect statistical data on freight transport conducted by freight vehicles registered in the respective countries since 1999. Like in Austria, data collection is usually arranged as a sampling survey. Thereby, small vehicles may be excluded, which is carried out differently among the member states. The states transfer the statistical data regularly to the statistical office of the European Union, Eurostat. From this data pool, Eurostat provides results (so-called **D tables**) in accordance with Regulation (EG) No 6/2003 to the national statistical authorities to complete their own national statistics.

Included are all reported journeys which start or/and end in or transit through Austria and which were conducted with freight vehicles registered in one of the reporting countries (EU-27 without Malta, including Norway, Switzerland and Liechtenstein). Journeys of smaller freight vehicles (mostly up to 3.5 tonnes loading capacity or 6 tonnes permissible maximum weight) are not included. As the results are derived from sampling surveys, there can be partly significant sampling errors.

Additionally, data from the Austrian **toll collection system** – which are provided by the Autobahnen- und Schnellstraßen-Finanzierungs-Aktiengesellschaft (ASFINAG) – are used for weighting the results from the D tables. Furthermore, results from countries that are not included in the D tables can be provided.

**Transport volume** is the amount of transported goods in tonnes (t).

**Transport performance** is the product of the transport volume and the distance travelled in kilometres (t\*km=tkm).
