1) Following applies for ÖNACE divisions **B05 until F43**: All enterprises of all divisions with 20 or more employees (without apprentices) are obliged to report. Additionally, for those divisions with turnover thresholds a reporting obligation applies to all enterprises with less than 20 employees where total revenues are greater than the indicated value (in thousand Euros). In the case of ÖNACE divisions **G45 onwards** the turnover threshold is given priority over the alternative employment threshold.

2) The special features are an additional part of the structural business statistics survey. All enterprises of the ÖNACE divisions G45 and G46 in the survey mass are asked to break down their revenues according to the Austrian Statistical Classification of Products by Activity (ÖCPA 2015) and residence of customers. For the features of 7B - 7K the employment threshold is decisive for the obligation to report.

3) For these divisions solely administrative data is used (Financial Market Authority (FMA), Austrian central bank (OeNB)).
