Regional Breakdowns

Statistics Austria is providing different regional breakdowns on the website. These can be administrative units (federal provinces, political districts, municipalities), breakdown of areas by function (regional electoral zones, NUTS units, urban regions, localities, statistical enumeration districts) or geometric area divisions (statistical grids). In order to provide a greater variety of data, predefined data-packages are offered for the different regional breakdowns.

Fees in € for Austria

The fees are published for the whole national territory of Austria. If ordering statistical enumeration districts a minimum sum of 109€ has to be paid. When taking the usage right "Commercial use excluding resale" a surcharge of 40% of the price has to be paid.

Confidentiality/Data Protection

For data protection reasons, characteristics for such samples are only given where the regions are sufficiently populated. The data protection threshold depends on the type of sample.

- **Objects:** without restrictions (number of persons with main residence, number of persons with secondary residence, number of daytime population, number of buildings, number of residential buildings, number of dwellings, number of usage units, number of buildings with dwellings, number of local units of employment (workplaces), number of employees, number of commuters at place of work place or educational institution, number of commuters at place of residence, number of households)
- **Population data:** characteristics relating to the resident population (demography, employment and education) are released only if at least 4 persons with main residence are registered in the region.
- **Household data:** characteristics relating to the households or household representatives are released only if at least 4 households are registered in the region.
- **Family data:** characteristics relating to families are released only if at least 4 families are registered in the region.
- **Buildings**: characteristics relating to buildings are released only if at least three buildings or three dwellings are registered in one region.
- **Dwellings**: characteristics relating to dwellings are released only if at least three dwellings are registered in one region.
- **Commuters at place of residence**: characteristics relating to commuters are released only if at least 4 commuters at place of residence are registered in the region.
- Commuters at place of work place or educational institution: characteristics relating to commuters are released only if at least 4 in-commuters are registered in the region.

- Local Units of Employment (workplaces): characteristics relating to LUE are released only if at least 3 local units of employment are registered in the region.
- **Employees**: characteristics relating to employees are released only if at least 4 employees are registered in the region.
- **Employees**: characteristics relating to employees are released only if at least 4 employees are registered in the region.
- **Daytime population**: characteristics relating to Daytime population are released only if at least 4 daytime-persons are registered in the region.
