## **Executive Summary**

The aim of the project "Register-based labour market careers (ERV)" is to carry out longitudinal evaluations from administrative data sources used for the Register-based census and the Register-based labour market statistics, respectively. For this purpose, overlap-free employment careers are created from various register data. The concepts of the Register-based labour market statistics<sup>1</sup> are adopted where possible.

The processed administrative data (e.g. from the Central social security register, Public employment service (AMS)) are linked and jointly made free of overlaps. Each person is thus assigned a unique labour market status for each day. The hierarchy of the Register-based labour market statistics is applied:

- 1. military/civilian service, maternity allowance/maternity leave, rehabilitation periods
- 2. active employment<sup>2</sup>
- 3. temporary absence
- 4. unemployment<sup>3</sup>
- 5. retirement benefits
- 6. pupils, students
- 7. other non-employed persons<sup>4</sup>
- 8. co-insured persons
- 9. main residence registration
- 10. no main residence in Austria

The following rules are used to determine the dominant gainful activity in the case of parallel gainful activities:

- 1. gainful employment and self-employment before marginal employment,
- 2. full-time employment before part-time employment,
- 3. in the case of equal-ranking employment, the one with the highest income dominates,
- 4. otherwise the one with the earliest start.

In the case of overlapping episodes of the same rank, the episode with the earliest start is given priority.

The e-Government act makes the linkage of administrative data possible, with absolute protection of data privacy. This is done with the help of the area-specific personal identifier official statistics (bPK-AS).

The protection of personal data is a central concern of Statistics Austria. Therefore, in order to make individuals unidentifiable in the results, the "record swapping" procedure is used for a defined percentage of the data. In this process, so-called "risky records" are identified - these are data records with rare combinations of characteristics, which would therefore be easier to identify. Individual characteristics of these persons are then swapped with the characteristics of other persons. Attention is paid to ensure that the most important key figures are not distorted. Due to the record swapping procedure, small values should be interpreted with caution.
