## **Executive Summary**

The survey on the travel habits of the Austrian resident population collects the number and profile of trips (outside the usual environment) made in Austria and abroad within a quarter. The socio-demographic profile of travellers and non-travellers is also collected. For this purpose, about 3,500 people per quarter are interviewed by telephone or online (population of approx. 7.56 million). Participation in the survey is **voluntary**. The selection frame for the **proportional stratified sample** is the Central Register of Residents (CRR). Phone numbers are taken from the public directory (Herold). The **telephone survey** (CATI - Computer Assisted Telephone Interviews) is done in the in-house call center of Statistics Austria. The survey infrastructure "STATsurv", developed by Statistics Austria, has the possibility of using mixed modes (CAWI, CATI). Furthermore, STATsurv automatically stores paradata such as response times for each question and offers standardised monitoring and reporting possibilities. The collected data are subjected to plausibility checks; implausible and missing data are imputed. After imputation, the extrapolation of the data and the creation of standard tables for publication are done.

## Data are collected for

- · holiday and business trips,
- with (overnight trips) and without an overnight stay (same-day visits),
- domestic trips and trips abroad.

In addition to the **profile of domestic and trips abroad** (duration of stay, travel destination, month of departure, purpose of travel, main mean of accommodation, organisation of the trip, main mean of transport and travel expenses) the socio-demographic profile of **travelers** and **non-travelers** is collected (gender, age, education, profession).

Data on travel habits of the Austrian population is available **since the reporting year 1969**. Until 2002 data were collected within the framework of the Austrian Microcensus as a special program. In accordance with **European Regulation on Tourism Statistics** and the **National Tourism Demand Statistics Decree**, the fieldwork of the data collection converted from a three-year or annual (1969-1996 three-year, 1998-2002 yearly¹) to a **quarterly survey cycle in the year 2000**. Since 2000 the data collection is a stand alone survey.

Data collection on travel habits represent an important source of information for all those who deal with the **tourism industry**, with **economic analysis** and **forecasts** and **market research**. Based on the data the economic importance of tourism is evaluated and findings are used for **tourism policy related decisions**. Internally the statistic is used for calculating the debit side of the "**Travel Balance of Payments**"(TBoP); furthermore, the available data related to domestic and outbound tourism is considered for calculations related to "**Tourism Satellite Account**" (TSA).

The **main results** of the surveys and anonymised microdata are transmitted to Eurostat and main results are available in the <u>Eurostat database</u>. A European user data-base containing all participating countries is disseminated by Eurostat.

Also on the <u>Statistics Austria website</u> selected results are presented quarterly and are available in <u>STATCube statistical database</u>. Anonymised micro data are available without charge for scientific use. In an annual summary report, the main results of the year are summarized and time series are presented. The results of the survey are also occasionally published in various other media (e.g. press releases).

The slightly unclear definition of the survey item, the risk of different interpretations and the "multi-purpose" nature of many trips is challenging. Furthermore, an under-reporting of individuals who are not available in the public phone book, can be assumed, therefor CAWI (Computer Assisted Web Interviews) was introduced in a mixed mode model in 2020. The fact that the results are based on retrospective surveys over a past period may cause recall problems which might lead to biased results. In addition, people with long-term trips and those travelling frequently are not sufficient captured.

Since the reference year 2018 **MNO** (mobile network operators) **data** support the extrapolation of survey weights. The previous extrapolation was based on the characteristics of age group, gender and federal province. These weights now serve as the basic weight for the calibration and the corresponding cross table is one of the tables to which it is adjusted. In addition to this table, the key figures based on the MNO data for the individual countries are also included in the calibration. The ipf function from the surveysd R package is used for calibration, iterative proportional fitting is used. Every respondent receives their own weighting factor for grossing up, whereas the weights are calculated for each record depending on the stratum and adjusted in such a manner that the resulting distribution is in accordance with the population within the federal province.

Due to changed and /or adjusted methodology, the results are limited comparable over time.
